### Spring Exam #11

Due date: June 3, 2013

1. Team A trails 19-14 after a safety and attempts an onside kick from the A-20. B7 blocks A7 into the ball at the A-28 and the ball rolls to the A-31 where B16 muffs the ball out of bounds at the A-26. A19 was offside on the kick.
2. 3/4 @ 50. B60 charges into snapper A50 prior to the snap, but the contact is not a personal foul. A61 retaliates by committing a personal foul on B60.
3. 2/20 @ A-3. Quarterback A12 tosses a backwards pass to A34 in his end zone but A34 muffs the ball up into the air. The ball has still not hit the ground when B79 bats it and it rolls over the end line.
4. 4/10 @ A-20. A15's punt lands at the B-20 where A82 muffs the ball into B32. A43 recovers it at the B-25. At the snap, Team A was flagged for an illegal formation.
5. 3/2 @ A-43. A12 takes the snap from shotgun formation and fakes a handoff to A22, then follows on a quarterback keeper as A22 blocks. A12 is met by linebackers B34 and B35 at the A-43. A22 grabs A12's jersey at the A-44 and pulls him forward to the A-46, where he is downed.
6. 4/14 @ A-6. A4's punt from his end zone is partially blocked. At the A-7, nose guard B72 gives a valid fair catch signal. Long snapper A50 shoves B72 in the chest, knocking him down. A50 turns and catches the punt at the A-6 and is tackled immediately. Time in the second period expires during the down.
7. 4/5 @ B12. With 8:45 to go in the fourth period, Team A trails 21-17. Team A is in field goal formation. At the snap, defensive back B20 runs forward from the B-5 and leaps in an attempt to block the field goal. The kick is good. B20 lands on top of center A50.
8. 2/8 @ B-22. B26 intercepts A12's legal forward pass at the B-4. His momentum is taking him into the end zone when he fumbles at the B-1 and is subsequently recovered in B's end zone by B48.
9. 1/goal @ B-7. A21 runs to B3 where he is tackled by the facemask by B54 and fumbles the ball into the end zone. To keep player B31 from recovering the ball, A71 grabs B31 by the leg, and then accidentally contacts the ball with his foot, causing it to roll out of the end zone.
10. Extra period. 3/2 @ B-17. After a charged team timeout, snapper A1 snaps the ball before the ball is made ready for play. A2 muffs the snap and B1 recovers the ball.
11. 4/6 @ B-16. Team A is in field goal formation. A50's snap is high and deflects off holder A10's hands at the B-23. Kicker A11 at the B-25 bats the ball forward while it is still airborne, into the hands of holder A10. A10 runs to the B-9 where he is knocked out of bounds.

12. 4/8 @ A-32. Score is A 27 - B 26. A75 snaps the ball over punter A1's head. To keep B18 from getting the ball A1 kicks the ball at the A-6 and it rolls out of bounds at the A-1. Time in the fourth period expired during the down.
13. 3/2 @ B-25. The ball is spotted on the right hash. B22 commits pass interference against A88 at the B-8 in the center of the field. Ball location after penalty enforcement?
14. 3/8 @ B-40. Eligible A80 is airborne near the sideline when he receives a legal forward pass. He maintains firm control of the ball as he comes to the ground facing the field of play, his toe touches the ground inbounds and then his heel comes down in a continuous motion on the sideline at the B-30.
15. 3/goal @ B-3. Score A 20 – B 21. Fourth period, 0:12 left and the game clock is running. Shotgun quarterback A1 muffs the snap. Back A2 catches the muffed ball and immediately throws the ball forward into the ground. The game clock reads 0:06.
